Preface

The focus on making use of modern texts and resources is one of the strong points for which there has been guidelines allocated to compilers via the geography departments. The present book is compiled based on the latest English texts related to rural planning. I hope that students enjoy studying the book to the greatest extent and learn new concepts and approaches that are very necessary for every rural planner.

Guidelines

Most geographical contents have many words and concepts that are necessary for master students to learn. This book represents new contents for geography students, and helps them learn how to translate the sentences and do exercises for learning more. Every unit of the book has three parts:

A. Aims

Every unit has General aims and Behavioral Objectives.

B. Words

Words consist of general words and key words. These words reflect extract from each chapter. Students learn them with explanation of dictionary and example. Then, they should do exercises according to the words. Some words are very specific in every course; they should learn them.

C. Context

Students should read every context carefully, and do the related exercises. They are about rural planning subjects. Students should obtain the main idea of each lesson. In each text there are new approaches that familiarize students with the latest results of the research and theories of rural planning. Therefore, comprehension and translation of the texts for students is really helpful and strengthens their comprehension and grammar skills.

D. Exercises

Vocabulary exercises

These exercises are divided into two parts:

1) Fill in the blank and 2) Matching words.

Comprehension questions

Comprehension questions consist of three types:

True/ False Statements

These questions are about key points in each chapter. To answer them, students should refer to the texts and find the best answer.

Multiple - choice Items

These questions require understanding the meaning of sentences completely, which are related to the meanings of words.

Word Formation

This part consists of different forms of each word like: verb, adjective, and noun. Students examine their abilities in determining of each form of words, and they can improve the usages of words in the sentences.

Translation

One of the aims of this book is learning the ways of translation. In this part students can translate each section into Persian. Every rural planner should understand the meaning of new words and relations between them. Students can use their grammatical knowledge to determine the structures of sentences and function of words in each sentence, then, join each words as a Persian sentence. Following this part, there is an exercise that students should write Persian equivalents of words in a chart.

Appendixes

Appendix1: Students in a self-study system are supposed to do exercises by themselves. They must check their answers in the answer keys. In appendix1, they can match their answers with answer keys for each unit.

Appendix 2: Students need the Persian equivalents of words for translation, and understanding the meaning of each unit. In appendix 2, Persian equivalent of each word is represented.

Students can match their own equivalent with equivalents of the book.

C. Content

Geography and Rural Geography

The distinction between "rural" and "urban" is probably inescapable for descriptive purposes; however, it often implies a dichotomy which encompasses both spatial and sectoral dimensions. In censuses and other similar statistical exercises, rural and urban populations are usually defined by residence in settlements above or below a certain size; agriculture is assumed to be the principal activity of rural populations whereas urban dwellers are thought to engage primarily in industrial production and

services. In reality, however, things tend to be far more complex: the ways in which nations define what is urban and what is rural can be very different; the boundaries of urban settlements are usually more blurred than portrayed by administrative delimitations, especially when towns use of rural resources is considered; population movement, especially temporary and seasonal migration, is not usually reflected in census figures and can make enumerations of rural and urban populations unreliable; finally, a large number of households in urban areas tend to rely on rural resources, and rural populations are increasingly engaged in nonagricultural activities.

Demographic and economic criteria on which definitions of urban and rural areas are based can vary widely between different nations, making generalizations problematic. In the Philippines, urban areas are defined by the national census as all settlements with a population density of at least 500 persons per square kilometer. The urban status also applies to centres with the following infrastructure:

- a parallel or right-angled street pattern;
- at least six commercial, manufacturing or similar establishments;
- at least three of the following: a town hall, church or chapel; a public plaza, park or cemetery; a market place or building where trading activities are carried out at least once a week; and a public building such as a school, a hospital or a library.

Asia remains a predominantly rural continent, with two-thirds of its population living in rural areas in 1990. However, if both India and China were to change their definition of urban centres to one based on a relatively low population threshold - as used by many Latin American and European nations - a large proportion of their population would change from rural to urban. In many nations, all settlements above a certain threshold, often 2,000 or 2,500 inhabitants and in some countries, only a few hundred inhabitants, are considered urban. A large proportion of India's and China's rural population live in settlements which under such definitions would be reclassified as urban. Since India and China have a high share of Asia's population this, in turn, would significantly change Asia's level of urbanization - and even change the world's level of urbanization by a few percentage points.

Rural geography is the study of people, places and environments in rural areas, with special reference to society, economy, politics and culture in the world. Rural geographers have widely differing interests, and are often closely associated with interdisciplinary research in rural areas with sociologists, economists and agricultural specialists. Indeed, in the USA there is little evidence of a specific sub-discipline called 'rural geography'.

Rural areas have traditionally been important to geography. The studies of rural settlement patterns by Paul Vidal de la Blache and Albert Demangeon, and the ensuing concern for agricultural land use and settlement systems,

stemming in part from the classical models of Von Thunen and Christaller, ensured that most human geographers would be familiar with aspects of rural space. With the demise of regionalism, however, rural areas were relatively neglected in geography until a distinctly demarcated subject area of 'rural geography' emerged in the 1970s. Prompted by Hugh Clout's (1972) book Rural geography: an introductory survey, the agricultural focus of rural work was expanded to cover aspects of society, economy and land, and the literature of rural geography burgeoned in the 1970s and 1980s; covering, for example, accessibility, agriculture, employment ,housing, land use, recreation and rural planning. Initially, there was a phase of resurgence for rural geography, particularly in parts of Europe, Canada and Australasia, but by the 1980s the bandwagon was again losing momentum. The general appetite for new information on the changing rural milieu had been satiated, and new challenges were required in order to generate fresh energy. In particular, rural geographers were urged to be more policy-orientated and more theoretically informed.

During the early 1980s much of rural geography was characterized by a form of 'applied positivism', a cobbled-together theoretical package which both acknowledged virtues and discourses of political economy and permitted researchers to carry on with positivistic methods and results as before. In this way rural geographers began to tackle issues relating to problems of policy and planning in rural areas, and yet were unwilling to replace their technical role with one which engaged directly with politics and ideology. In some cases, rural geography was therefore seen to be 'broadly theory-free', while others saw the sub-discipline as 'tinkering with existing socio-economic conditions in order to weaken the impress of malevolent trends [while failing] to recognise that the processes which brought about current misdistributions are inherent in policy procedures.
